- Two members of the Committee are looking into establishing a women's Bible study.
- St. Paul's UCC-Birdsboro will be holding a hoagie sale on November 8 and 9. Ten percent of the proceeds will be donated to St. Paul's UCC-Amity for the food pantry.

- The Committee will replace the non-functioning security camera with a working camera to determine whether the malfunction is in the camera or in the wiring.
- The wedding request forms have been updated to include an option to use the soundboard.
- Plans must be finalized to provide personnel to operate the sound system for the Christmas Pageant and the three Christmas Eve services.

- Preparations have begun to demolish the wall dividing the two rooms that will comprise the new youth area.
